

**Position:** Farm Unit Manager (Gianella Stewardship)

The Permanent Plantings Division, one of the company's business units, includes (among other operations): Almonds and Pistachios in Wasco, CA; Walnuts and Prunes in Chico, CA.

**Description:** The Farm Unit Manager under direction of Farm Manager carries out the crop plan in a safe, efficient, effective and timely manner to ensure optimization of costs, yields and quality to maximize returns to the owner. The Farm Unit Manager has responsibility for all aspects of crop production (employee supervision, tree health, pest control, etc.) under his/her stewardship.

## **Essential Duties and Responsibilities:**

- Ensures the crop plan is carried out to achieve operational targets.
- Ensures irrigation applications are made relative to pressure bomb readings. Soil
  moisture maintained at optimal levels, mid-day stem water potential within
  acceptable ranges; Systems operating at correct pressures with no major issues
  (leaks, plugging, etc.).
- Ensures fertilizer & gypsum/Lime applications are +/- 5% relative to application schedules (in accordance with crop plan timing).
- Ensures orchard sanitation mummy nut removal meets standard of <1 nut per tree and destruction completed by crop plan date.
- Trains & develops subordinates in current role as well as future leadership.
- Ensures young trees (new plantings and resets) have a -98+% survival rate with optimal growth on 95+%.
- Meets or exceeds accomplishment rates for each cultural operation established by production team.
- Ensures team follows health and safety regulations. Maintains the farm's OSHA Frequency Rate at or below industry average.
- Identifies problems with crop and makes recommendations for correcting.
- Notifies Management of issues and/or variances along with corrective recommendations within 24 hours.

- Meets or exceeds business yield models 2-year average.
- Meets or exceeds established quality goals.
- Ensures cost per unit on "Financial Report" is within budget.
- Assists with creation of operating budget and explains variances to the budget.
